Requests for refunds of fees paid must be submitted in writing to IronWill Football at PO Box 21078, Red Deer, Alberta T4N 1N0 not less than 30 days prior to the selected camp session and will be subject to an administration fee of \$55.00 per session, but there will be no refund of fees for requests received within 15 days prior to the selected camp session.
- 2) I give IronWill Football, its employees, agents and subcontractors, the sole and exclusive right to use pictures and videos of my child taken during the camp for advertising and/or instructional purposes.
- 3) I do hereby release, remise and forever discharge IronWill Football, its employees, agents, subcontractors, assigns, administrators and appointees of and from all manners of actions, causes of action, suits, debts, claims, costs and demands whatsoever which I may have as against the said IronWill Football arising from, related to, or as a direct result of the participation by my child in the sport camp activities operated by IronWill Football.
- 4) I give my permission for the employees and agents of IronWill Football to provide and seek any emergency medical assistance my child may require while attending the selected camp session.
- 5) I acknowledge that I have read and understand the terms and conditions of this agreement and certify that my child is in good physical and mental health.
